Credit to Rell On Wheels Photography (e.g., "Photo by Rell On Wheels Photography") is required when publishing Images on public platforms, unless otherwise agreed.

The Client/Model hereby grants Rell On Wheels Photography permission to use, publish, and distribute the Images in any form of media, including print, web, advertising, or exhibitions, unless otherwise agreed in writing.

5. Liability & Release
